A RESOLUTION HONORING PAT	TTI KOLLER OF CRIPPLE CREEK

COMMUNICATIONS, AS TELECOMMUNICATOR OF THE THIRD OUARTER 2015.

WHEREAS, the El Paso - Teller County Emergency Telephone Service Authority was created to provide a two-county-wide E9-1-1 system; and

WHEREAS, the members of the Authority wish to recognize outstanding call takers and dispatchers within the system through the Telecommunicator of the Quarter and Telecommunicator of the Year programs; and

WHEREAS, On July 30th it was a busy shift in Cripple Creek with calls to include a disruptive man in a casino and people in the lobby. Job duties include call-taking, dispatching and assisting citizens. Dispatchers often work alone but on this day there were two on duty. Dispatcher Patti Koller answered the phone calmly and repeated, "He fell down a mine shaft?" Patti remained composed while gathering information. Responders had difficulty locating the remote mine shaft and she stayed in contact with the neighboring PSAP coordinating and relaying information.

WHEREAS, High Angle Rescue, Mine Rescue, Mutual-aid Fire and Medical and Flight for Life responded. Patti provided excellent customer service with the phone calls she made to those that continued to come in. Through teamwork the responders got the man out of the mine shaft. He was flown to the hospital with serious injuries and required treatment in a hyperbaric chamber due to the gases in the shaft.

WHEREAS, What makes Patti's professionalism and ability to process this difficult call so outstanding is that she was in the "application" phase of her training and had only been on the job for 58 days. Her trainer provided backup, but it was Patti who calmly and professionally managed the majority of this call. Dispatching is a challenging profession and Patti is demonstrating that she has what it takes. Cripple Creek is fortunate to have Patti on their team.
