



Resolution 22-08

Authority Member JAMES moved approval of the following resolution:

A RESOLUTION HONORING RYAN SANDERSON OF THE COLORADO SPRINGS POLICE DEPARTMENT AS TELECOMMUNICATOR OF THE THIRD QUARTER 2022.

WHEREAS, the El Paso – Teller County Emergency Telephone Service Authority was created to provide a two-county-wide 9-1-1 system; and

WHEREAS, the members of the Authority wish to recognize outstanding call takers and dispatchers within the system through the Telecommunicator of the Quarter and Telecommunicator of the Year programs; and

WHEREAS, On July 15, 2022, Ryan dispatched a chaotic Family Disturbance call with multiple parties involved. While officers were enroute to the call, it was discovered the suspect had a warrant. Upon officers' arrival on scene, the suspect fled, and a foot chase began. Ryan did an excellent job using his resources to include mapping tools to keep responding officers informed of the suspect's location. Ryan set up containment to prevent the subject from fleeing further. Elevating the danger, the suspect was an officer safety risk with a history of assault on peace officers and known to be armed.

WHEREAS, While reviewing other pending calls in his division, Ryan noticed a call in the vicinity of his foot pursuit which turned out to be the suspect the officers were searching for. Ryan immediately adjusted his containment and re-directed his officers to better locate the suspect. Ryan provided a great deal of critical information to the responders which was instrumental in capturing the suspect.

WHEREAS, Throughout the duration of the call, Ryan exhibited exceptional command and control of the incident which undoubtedly was key in resolving the situation without injury. Ryan deserves recognition for the critical role he played in helping officers get a wanted and dangerous individual off the streets.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

The El Paso – Teller County 9-1-1 Authority honors Ryan Sanderson as Telecommunicator of the Third Quarter of 2022.
